

IN West Tulsa, Okla. now a part of the City of Tulsa, Okla. as per the recorded plat thereof.

TO HAVE AND TO HOLD THE SAME, Together with all and singular the tenements, hereditaments and appurtenances thereunto belonging or in anywise appertaining forever.

PROVIDED ALWAYS, And these presents are upon this express condition, that whereas said parties of the first part ha---- this day executed and delivered a certain promissory note in writing to said party of the second part, for the sum of \$550.00, said note being dated Dec. 18, 1923 and maturing on Dec 18th 1924. Said note is signed by W. C. Tilford and Bertie Tilford. Said note is due and payable at the West Tulsa State Bank, West Tulsa, Okla. Note draws interest at the rate of 10 per cent after maturity. Said note bears an attorneys fee clause of \$55.00, and the first parties agree to keep the buildings insured for \$550- , and the mortgagor agree to pay \$55.00 attorney's fees on foreclosure.

Now if said parties of the first part shall pay or cause to be paid to said party of the second part her heirs or assigns, said sum of money in the above described note mentioned, together with the interest thereon according to the terms and tenor of the same, then these presents shall be wholly discharged and void, and otherwise shall remain in full force and effect. But if said sum or sums of money, or any part thereof, or any interest thereon, is not paid when the same is due, and if the taxes and assessments of every nature which are or may be assessed and levied against said premises, or any part thereof are not paid when the same are by law made due and payable, then the whole of said sum or sums and interest thereon shall, and by these presents become due and payable, and said party of the second part shall be entitled to the possession of said premises, and the said parties of the first part for said consideration, do hereby specially waive an appraisalment of said real estate, and all the benefit of the homestead, exemption and stay laws of the State of Oklahoma.
