QUIT CLAIM DEED

COMPARED

THIS INDENTURE, Made this 10th day of December in the year A. D. 1923 between  
Eugene W. Davis and Gerty Davis, husband and wife, of the first part, and L. B. Cooper  
of the second part.

WITNESSETH, That the said parties of the first part, in consideration of the sum  
of One Dollar and other valuable considerations to them duly paid, the receipt of which is  
hereby acknowledged, do hereby quit claim, grant, bargain, sell and convey unto the said party  
of the second part, and to his heirs and assigns, forever, all right, title, interest, and  
estate, both at law and in equity, of, in, and to the following described real estate situate  
in the County of Tulsa, State of Oklahoma, to-wit: Beginning at the Southeast corner  
of the Northwest Quarter of the Southwest quarter of Section 20, Township 17 North, Range  
13 East, thence North Sixteen (16) feet, thence West to the Section Line between Section 19  
and 20, thence South on said Section line Sixteen (16) feet, thence East on line between  
the Southwest quarter (SW $\frac{1}{4}$ ) of Southwest quarter and the Northwest quarter (NW $\frac{1}{4}$ ) of said  
Southwest quarter (SW $\frac{1}{4}$ ) of Section Twenty (20) Township and Range ---- aforesaid to the place  
of beginning in Tulsa County, Oklahoma.

This deed given for the purpose of making correction in the acknowledgment of a certain deed  
given under date of June 24, 1921, recorded Book 371, on page 59, of the records of Tulsa  
county, Oklahoma, together with all and singular the hereditaments and appurtenances thereunto  
belonging.
