DECLARATION OF TRUST.

KNOW ALL MEN BY THESE PRESENTS:

COMPARED

THAT, WHEREAS, by a deed dated the 27th day of April, 1923, and recorded in the office of the County Clerk of Tulsa County, State of Oklahoma, in Book 459 at page 25 of the records of deeds, there was conveyed to me by F. A. Gillespie and Maud Gillespie, husband and wife, the following described real estate, to-wit:

All of Lots Five (5) to Sixteen (16) inclusive in Block Nine (9)
and Lots One (1) to Ten (10) inclusive in Block Sixteen (16) Park Hill
