REAL ESTATE MORTGAGE

COMPARED

THIS INDENTURE, Made this 17th day of December A. D. 1923, by and between W. R. Shackleton and wife, Ida M. Shackleton of Tulsa, County, State of Oklahoma, of the first part, and Robt. E. Adams of the second part,

WITNESSETH: That the said parties of the first part, in consideration of the sum of One and No/100 DOLLARS, to them in hand paid, the receipt of which is hereby acknowledged, have granted, bargained and sold, and by these presents do grant, bargain, sell and convey unto said party of the second part his heirs and assigns, forever, all the following described real estate, situated in the County of Tulsa State of Oklahoma, to-wit:

All of Lot Eighteen (18) in Block Two (2) of Ridgedale Terrace Addition to the City of Tulsa, Oklahoma, according to the recording plat thereof, with the appurtenances and all the estate, title and interest of the said parties of the first part herein. And the said parties of the first part do hereby covenant and agree that at the delivery hereof they are the lawful owners of the premises above granted, and seized of a good and indefeasible estate of inheritance therein, free and clear of all incumbrances first mortgage in the sum of \$4500 in favor of the Oklahoma City Building and Loan Association.

This grant is intended as a mortgage to secure the payment of the sum of Six Hundred Seventy-five and No/100 DOLLARS, according to the terms of five certain promissory notes, this day executed and delivered by the said parties of the first part to the said party of the second part, described as follows, to-wit:

Four notes for the sum of \$25.00 each dated October 16, 1923 numbered 14 to 17, inc. the first note maturing on the 15th day of December, 1923 and one note on
