to growing crops and fences that may arise by reason of operations thereon. If Oil or Gas is found in paying quantities in any well drilled, the privilege of operating shall continue so long as Oil or Gas may be produced in paying quantities and when abandoned for such purposes this grant shall cease and no longer be binding on either party. If gas is found on the above described land the party of the firstpart to have the use for domestic purposes

The second party reserves the right to remove all pipe, machinery and fixtures placed there on by them, including casing in wells. No well shall be drilled within less than two hundred feet of any building now on the premises without the consent of first party. The party of the second part shall have a right to use free of cost Gas. Oil and Water on said land for operating thereon except Water from wells of first party.

The Co-operative Oil Company of Kansas shall pay to the lessor \$65.00 when a paying oil or gas producing well is finished . If the first well drilled is not a producer in paying quantities then the \$65.00 above mentioned shall be cancelled and considered paid by the Co-operative Oil Company of Kansas and said Company shall have the privilege of other wells on the premises without further money payments but the royalties from wells if oil or gas is struck in paing quantities and sold off the premises, Post office Address of the Co-operative Oil Company of Kansas is Vinland , Douglas County, Kansas.
