DECLARATION OF TRUST

of

THE OSAGE RIG. REAL & LUMBER ABSOCIATION.

This Declaration of Trust made this 12th day of January, 1921, WITNESSETH: That whereas, Frank M. Mahan, contemporaneously with the execution of this instrument, transfers and assigns to Earnest McCarty, Carl H. Besse and Frank M. Mahan, trustees as hereinafter set forth, all of his right, title and interest in and to one certain lease heretofore executed to the said Frank M. Mahan, by George Shell, covering the following described property in Osage County, to-wit: That piece or parcel of land described as follows: Commencing at the Northeast corner of a tract of ground occupied by W. Besse as trustees, do hereby declare that said property and all of said property when lawfully conveyed in accordance with the Declaration of Trust together with any property here inafter acquired with the proceeds arising from the said propperty and said proceeds themselves and any and all right, profit and income arising out of the said described property so conveyed, delivered and set over as aforesaid, shall be held with them upon the trust hereinafter set forth, to-wit:

l.-- The Trustees in their collective capacity shall be known as the Osage Rig. Reel & Lumber Association.

2. The Trustees shall issue certificates in substantially the form hereinafter set out for Two Hundred Forty shares of the nominal par value of \$100.00 each in payment for the transfer of the lease in Burbank, Oklahoma, the lots in Kaw City, and moneys and other personal property to be transferred, delivered and set over as aforesaid. The whole of said consideration shall be taken and deemed as moving to the said Frank M. Mahan, Earnest McCarty and Carl H. Besse assignors as aforesaid, but the said Frank M. Besse having agreed thereto and in lieu of cash payment to them for and in consideration of the above described property do hereby agree that said shares shall be issued as follows:
