same a reasonable and fair compensation as it will appear right and just in the judgment of the said trustees.

14.-- The words "Shareholder" or "Shareholders" as used herein shall be construed to mean those who are for the time being recorded as such upon the books of the trustees and to only such shall the trustees be responsible.
