DECREE

And now on this 23rd day of May, 1922, the same being a regular court day of the May, 1922, term of the District Court of Oklahoma County, Oklahoma, the above entitled cause came on for hearing on the petition of the plaintiff, Serena Mayers, and the amended answer of defendants, Robert S. Mayers, David Campbell Mayers, Marion Thorne and Herbert Mayers, the plaintiff appearing in person and by her record attorneys, Selby & Callihan, and defendants appearing in person and by their record attorneys, John J. Carney and Ledbetter, Stewart, Bell & Ledbetter, and all parties announcing ready for trial, and in open court waiving trial by jury, and consenting to trial of the cause to the court, and, after hearing the testimony of witnesses on behalf of plaintiff and defendants, all duly sworn and testifying in open court, and afterward, on examination of the documentary evidence submitted by the parties hereto, and of the pleadings in this cause, and the hour of adjournment of court for the day having arrived, trial hereof is adjourned until tomorrow morning, May 23rd, 1922 at the hour of 9 o'clock, A. M. p and now at this hour of 9 o'clock, A. M., of the 23rd day of May, 1922 this cause again comes on for hearing, pursuant to order of adjournment, the said parties and their said record attorneys being present, and after hearing argument of the said attorneys for the respective parties hereto, the court takes this cause under advisement.;

And now again, on this 21st day of September , 1923, same being a regular court day of the September, 1923, term of this court, this cause again comes on for hearing before the court, the parties hereto appearing by their said attorneys, whereupon, the court, upon a full consideration of all of the testimony and evidence submitted by the parties hereto, the pleadings and argument of counsel, and being fully advised, finds all of the issues in favor of the said plaintiff and against the defendants, and finds the allegations of plaintiff's petition to be fully sustained by the evidence, and that plaintiff is entitled to the relief therein prayed.

The court expressly finds that plaintiff was the wife of one S. L. Mayers, by marriage in October, 1892; that said S. L. Mayers departed this life in Oklahoma County, Oklahoma, on the 11th day of June, 1920, leaving a last will and testament which was duly probated in cause \$4310, entitled " In The Eatter of the Estate of S. L. Mayers, Deceased, in the County Court of Oklahoma County, Oklahoma, on the 17th day of January, 1921, which said will provided as follows:

" I hereby give and bequeath to my wife Serena Mayers Two Thirds (2/3) of all my property (Real Estate) as shown by the county records of Oklahoma County and Tulso County Oklahoma and Tarrant County, Texas- also all of my personal property that I may be possessed of at the time of my death - The remaining One Third of my real estate I give
