ORDINANCE NO. 2565.

An Ordinance adding and annexing to the City of Tulsa, Oklahoma, a certain tract of land within Tulsa County, Oklahoma, described as follows, to-wit: Beginning at the Northwest corner of the Southwest Quarter (SW $\frac{1}{4}$) of the Northwest quarter of Section 18, Township 19 North, Range 13 East; thence East along the North line of said Southwest quarter a distance of one thousand two hundred and eleven and five-tenths (1,211.5) feet (more or less) to the Northeast corner thereof, said corner being on the West line of Terwilliger Heights, an Addition to the City of Tulsa, Oklahoma, according to the official plat thereof; thence South along the East line of said Southwest quarter a distance of eight hundred and fifteen and thirty-four hundredths (815.34) feet; thence West, along the North line of the street bordering on the North side of Block 2, Travis Heights Addition to the City of Tulsa, Oklahoma, according to the official plat thereof, a distance of one thousand two hundred and sixteen and nineteen-hundredths (1,216.19) feet to the West line of said Section 18; thence North along said West line to the point of beginning, and declaring an emergency.

WHEREAS, it has been made to appear to the Mayor and Board of Commissioners of the City of Tulsa, Oklahoma, that the hereinafter described tract of land, situated in Tulsa County, Oklahoma, lies contiguous to and adjoins the present corporate limits of the City of Tulsa, Oklahoma, on three or more sides.

WHEREAS, it further appears to the Mayor and Board of Commissioners of said City that the said tract of land hereinafter described abuts said City on three or more sides and should be annexed to the City of Tulsa and entered within its corporate limits and that said tract of land does not exceed forty acres.

NOW, THEREFORE, BE IT ORDAINED BY THE MAYOR AND BOARD OF COMMISSIONERS OF THE CITY OF TULSA, OKLAHOMA:

SECTION 1. That a tract of land abutting on three sides with the corporate limits of the City of Tulsa, Oklahoma, situated in Tulsa County, Oklahoma, more particularly described as follows, to-wit:

Beginning at the Northwest corner of the Southwest quarter (SW $\frac{1}{4}$) of the Northwest Quarter (NW $\frac{1}{4}$) of Section 18, Township 19 North, Range 13 East; thence East along the North line of said Southwest quarter a distance of one thousand two hundred and eleven and five-tenths (1,211.5) feet (more or less) to the Northeast corner thereof, said corner being on the West line of Terwilliger Heights, an Addition to the City of Tulsa, Oklahoma, according to the official plat thereof; thence South along the East line of said Southwest quarter a distance of eight hundred and fifteen and thirty-four hundredths (815.34) feet; thence West, along the North line of the street bordering on the North side of Block 2, Travis Heights Addition to the City of Tulsa, Oklahoma, according to the official plat thereof, a distance of one thousand two hundred and sixteen and nine-teen-hundredths (1,216.19) feet to the west line of said Section 18; thence North along said West line to the point of beginning.
