An Ordinance adding and annexing to the City of Tulsa, Oklahoma, a certain tract of land within Tulsa County, Oklahoma, described as follows towit: Beginning at the Northeast corner of the Northwest quarter of the Southeast quarter of the Southeast Quarter of Section 26, Township 20 North, Range 12 East; said corner being the Northwest corner of Melrose 2nd Addition to the City of Tulsa, Oklahoma, according to the duly recorded plat thereof; thence

South along a line parallel to and thirty (30)feet West of the West line of Block 2 of said Melrose 2nd Addition a distance of six hundred and sixty (660) feet; thence West along a line parallel to and thirty (30) feet North of the North line of Block 1 Englewood Addition to the City of Tulsa, Oklahoma, according to the official plat thereof, a distance of three hundred and thirty-three (333) feet; thence North along a line parallel to and twenty (20) feet East of the East line of Block 1. Englewood 2nd addition to the City of Tulsa, Oklahoma according to the official plat thereof, a distance of six hundred and sixty (660) feet; thence East a distance of three hundred and thirty-three (333) feet to the point of beginning and declaring an emergency.

WHEREAS, it has been made to appear to the Mayor and Board of Commissioners of the City of Tulsa, Oklahoma, that the hereinafter described tract of land, situated in Tulsa County, Oklahoma, lies contiguous to and adjoins the present corporate limits of the City of Tulsa, Oklahoma on three or more sides.

WHEREAS, it further appears to the Mayor and Board of Commissioners of said city that the said tract of land hereinafter described abuts said city onthree or more sides and should be annexed to the City of Tulea and entered within its corporate limits and that said tract of land does not exceed forty acres, NOW THEREFORE BE IT ORDAINED BY THE MAYOR AND BOARD OF COMMISSIONERS OF THE CITY OF TULSA,

SECTION 1. That a tract of land abutting on three sides with the corporate limits of the City of Tulsa, Oklahoma situated in Tulsa County, Oklahoma, more particularly described as follows, to-wit:

Beginning at the Northeast corner of the Northwest Quarter of the Southeast Guarter of the Southeast quarter of Section 26, Township 20-North, Range 12-East; smid corner being the Northwest corner of Melrose Second Addition to the City of Tulsa, Oklahoma, according to the duly recorded plat thereof; thence South along a line parallel to and thirty (30) feet West of the West line of Block 2, of smid Melrose Second Addition a distance of six hundred and sixty (660) feet; thence West along a line parallel to and thirty (30) feet North of the North line of Block 1, Englewood Addition to the City of Tulsa, Oklahoma, according to the official plat thereof, a distance of three hundred and thirty-three (333) feet; thence North along a line parallel to and twenty (20) feet East of the East line of Block 1, Englewo od Second Addition to the City of Tulsa, Oklahoma plat thereof, a distance of six hundred and sixty (660) feet; thence East a distance of three hundred and thirty-three (333) feet to point of beginning;

be and the same is hereby added to and annexed to the said City of Tulss, Oklahoma, and the corporate limits of said City be and same hereby are extended to include said tract of land for all purposes.

SECTION 2. That the City of Tulsa, Oklahoma, hereby retains and reserves a perpetual easement and right to enter upon and use any portion of the above described tract of land and to build, construct, lay, maintain, alter or repair any sewer lines, water lines, gas lines, telephone lines, telegraph lines, electric lines or any other public utilities.
