ORDINANCE NO. 2546.

An Ordinance adding and annexing to the City of Tulsa, Oklahoma, a certain tract of land, known as HOPPINGS ADDITION to the City of Tulsa, Tulsa County, Oklahoma, according to the duly recorded plat thereof, and declaring an emergency,

WHEREAS, it has been made to appear to the Mayor and Board of Commissioners of the City of Tulsa, Oklahoma, that a certain tract of land known as HOPPINGS ADDITION to the City of Tulsa, Oklahoma, hereinafter particularly described lying in Tulsa County, Oklahoma, and lying contiguous to and adjoining the present corporate limits of said City, is surrounded on three or more sides by the corporate limits of the City of Tulsa and abuts on the City of Tulsa, on three or more sides, and

WHEREAS, it has been made to appear to the Mayor and Board of Commissioners that the said tract of land hereinafter described should be added and annexed to the City of Tulsa, Oklahoma, and included within the corporate limits of said City, and it further appears that said tract of land is not in excess of forty (40) acres.

NOW THEREFORE, BE IT ORDAINED BY THE MAYOR AND BOARD OF COMMISSIONERS OF THE CITY OF TULSA, OKLAHOMA:

SECTION--1: That a tract of land hereinafter described, the same being known as HOPPING ADDITION to the City of Tulsa, Tulsa County, Oklahoma, and adjoining the present corporate limits of said City, more particularly described as follows, to-wit:

Beginning at the Northeast corner of the Southeast quarter (SE $\frac{1}{4}$) of Section 7, Township 19 North, Range 13 East; thence South along the East line of said Section 7 a distance of eight hundred and ninety-seven and four-tenths (897.4) feet; thence West along the South line of said Hopping's Addition a distance of five hundred and sixteen and five-tenths (516.5) feet to the Southwest corner thereof; thence North along a line parallel to the East line of said Section 7, said line being the West line of Block 2, of said Hopping's Addition, a distance of eight hundred and ninety-seven and four-tenths (897.4) feet to the East and West center line of said Section 7; thence East along said center line a distance of five hundred and sixteen and five-tenths (516.5) feet to the point of beginning be and the same is hereby added and annexed to said City of Tulsa to be known as HOPPING'S ADDITION to said City and That the corporate limits of said City be and the same are hereby extended to include the above described tract of land.

SECTION 2; That the City of Tulsa, Oklahoma, hereby retains and reserves a perpetual easement and right to enter upon and use any portion of the above described tract
