ORDINANCE NO. 2568.

COMPARED

An Ordinance adding and annexing to the City of Tulsa, Oklahoma, a certain tract of land, known as FAUNSDALE ADDITION to the City of Tulsa, Tulsa County, Oklahoma, according to the duly recorded plat thereof, and declaring an emergency.

WHEREAS, It has been made to appear to the Mayor and Board of Commissioners of the City of Tulsa, Oklahoma, that a certain tract of land known as FAUNSDALE ADDITION TO THE City of Tulsa, Oklahoma, hereinafter particularly described, lying in Tulsa County, Oklahoma, and lying contiguous to and adjoining the present corporate limits of said City, is surrounded on three or more sides by the corporate limits of the City of Tulsa, and abuts on the City of Tulsa on three or more sides, and,

WHEREAS, it has been made to appear to the Mayor and Board of Commissioners that the said tract of land hereinafter described should be added and annexed to the City of Tulsa, Oklahoma and included within the corporate limits of said City, and it further appears that said tract of land is not in excess of forty (40) acres.

NOW, THEREFORE, BE IT ORDAINED BY THE MAYOR AND BOARD OF COMMISSIONERS OF THE CITY OF TULSA, OKLAHOMA:

SECTION 1. That a tract of land hereinafter described, the same being known as FAUNSDALE ADDITION to the City of Tulsa, Tulsa County, Oklahoma, and adjoining the present corporate limits of said City, more particularly described as follows, to-wit:

Beginning at the Southwest corner of the Southeast Quarter (SE $\frac{1}{4}$) of Section 26, Township 20 North, Range 12 East; thence North along the West line of said Southeast Quarter (SE $\frac{1}{4}$) a distance of four hundred and sixteen and eighty-four hundredths (416.84) feet to the Northwest corner of Block 1, of said Faunsdale Addition; thence East along the North line of said Faunsdale Addition a distance of three hundred and thirteen and five-tenths (313.5) feet to the Northeast corner of Block 2 of said Faunsdale Addition; thence South along the East line of said Block 2 a distance of four hundred and sixteen and eighty-four hundredths (416.84) feet to the South line of said Section 26; thence West along said South line a distance of three hundred and thirteen and five-tenths (313.5) feet to the point of beginning and the same is hereby added and annexed to the said City of Tulsa to be known as FAUNSDALE ADDITION to the City of Tulsa, Oklahoma, and that the corporate limits of said City be and the same are hereby extended to include the above described tract of land.

SECTION 2. That the City of Tulsa, Oklahoma, hereby retains and reserves a perpetual easement and right to enter upon and use any portion of the above described tract of
