

land being in Tulsa County, Oklahoma, and contiguous to and adjoining the present corporate limits of said City of Tulsa, praying that this Board annex to said City of Tulsa said tract of land; and

COMPARED

WHEREAS, it has been made to appear upon examination by this Board that the tract of land herein described is subdivided in such a way that the same meets the approval of this Board, and it further appearing to this Board that the prayer of said petition should be granted and that said land embraced within the tract herein mentioned should be annexed to the said City of Tulsa and that said action is for the best interest of all parties concerned,

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF COMMISSIONERS OF THE CITY OF TULSA, OKLAHOMA:

Section 1, That the tract of land herein described, the same being known as a portion of Riverford Addition and being a part of Lot 7 in Section 11, Township 19 North, Range 12 East, and more particularly described as follows, to-wit:

Beginning at a point on the east line of said Section 11, said point being 360 feet south of the northeast corner of the southeast quarter of said Section 11, thence south 124 feet; thence west 330 feet; thence north 124 feet; thence east 330 feet to the place of beginning, be and the same is hereby annexed to said City of Tulsa, Oklahoma, and that the corporate limits of said City of Tulsa, Oklahoma, be and the same are hereby extended to include the above described tract of land.

Section 2. That from and after this ordinance takes effect the real estate described and bounded in Section 1 hereof shall be and the same is hereby declared to be a part of the City of Tulsa, Oklahoma, and all persons residing therein and all property situated thereon shall be and are hereby declared to be subject in all respects and particular to the jurisdiction, control, laws and ordinances of said City of Tulsa.

Section 3, That an emergency exists for the preservation of the public health and safety, by reason whereof this ordinance shall take effect from and after its passage, approval and publication.

PASSED and the emergency clause ruled upon separately and approved this 18th day of May, 1917.
