Tilton, his wife, Frank F. Tilton, Wilma M. Tilton his wife, Benton M. Bowers, Nettie Bowers, his wife, Jennette Docherty, of Tulsa County, Oklahoma, hereinafter called lessors, and H. R. Hughes of Tulsa County, Oklahoma hereinafter called lessee:
