THIS DECLARATION OF TRUST made this 21st day of January, 1924, by the law firm of Wesley, Atkins & Chandler, being a partnership engaged in the practice of law in the State of Oklahoma, with offices at Muskogee, Muskogee County, in said State, as the Grantor, and CARTER W. WESLEY, J. ALSTON ATKINS, and CHARLES A. CHANDLER, as THE TRUSTEES, WITNESSETH THAT,

Whereas the grantor and settlor of this trust, the said law firm of Wesley, Atkins & Chandler, has made and executed the above assignment and transfer as therein set forth, and has delivered the goods, chattels and personal property therein described to the above named Trustees of this trust as therein set forth.

NOW, THEREFORE, we, the said grantor and Trustees, do hereby create and declare the following express trust:

#### ARTICLE I

##### Style of Trust

Section 1. NAME. This trust shall be known and designated as "THE CONQUEST TRUST", and the Trustees shall execute all instruments and carry on all of the business of this trust under that name.

Section 2. SEAL. This trust shall have a seal, which shall be circular in form and capable of being impressed on paper. It shall bear on its face the words and figures: "THE CONQUEST TRUST, SEAL", and such other words, figures and designs as the Trustees may hereafter decide upon.

Section 3. SIGNATURE. All documents or instruments requiring the signatures of the Trustees shall be signed as follows: " The Conquest Trust ", by such TRUSTEE or TRUSTEES, officers or agents as the Trustees may appoint for this purpose.

SECTION 4. PRINCIPAL PLACE OF BUSINESS. The principal place of business of this trust shall be located at such place in the United States of America as the Trustees may from time to time decide upon.
