ORDINANCE NO. 2530.

An ordinance accepting and adding to the City of Tulsa, Oklahoma, certain tract of land known as SUNSET VIEW ADDITION to the CITY OF TULSA, Tulsa County, Oklahoma; according to the recorded plat of Sunset View Addition, changing the name of Twenty-Seventh Street to TWENTY-NINTH STREET, and declaring an emergency.

WHEREAS, a petition in writing have been presented to the Mayor and Board of Commission ers of the City of Tulsa, Oklahoma , signed by the property owners of the tract of land Herein described and designated as SUNSET VIEW ADDITION to the City of Tulsa, Oklahoma, said tract of land being in Tulsa County, Oklahoma, and lying contiguous to and adjoining the present corporate limits of said City, which petition prays that said Board annex to said City of Tulsa said Tract of land, and,

WHEREAS, it has been made to appear upon examination by said Board that the tract of land herein described, is platted into lots and blocks and is used for residential purposes; and it further appearing to said board that the prayer of said petitioners should be granted and the land embraced in said petition should be annexed to said City and that all things necessary to be done for the proper annexation of said tract of land to said City, have happened and been performed, and that said action is for the benefit of all parties concerned.

NOW THEREFORE, BE IT ORDAINED BY THE BOARD OF COMMISSIONERS OF THE CITY OF TULSA, STATE OF OKLAHOMA.

SECTION 1, That a tract of land hereinafter more particularly described, the same being known as SUNSET VIEW ADDITION to the City of Tulsa, Oklahoma, and adjoining the present corporate limits of the said City, being described as follows, to-wit:

/ A tract of land beginning at the northwest corner of Lot 3, Section 18, Township 19 north, Range 13 east, Tul sa County, Oklahoma, thence south along the west line of said Bot 3 a distance of 330 feet, thence east a distance of 1320 feet, thence north 330 feet, thence west along the east and west quarter section line of said section 18, a distance of 1320 feet to a point of beginning, containing ten acres less 15 feet for a public road running north and south along east line of said tract; and that the plat shown herewith is a true and correct map of said survey all distances measured in feet and decimals there of, be and the same is hereby annexed to said City of Tulsa, Oklahoma, to be known as SUNSET VIEW AUDITION to the City of Tulsa, Oklahoma,; and the corporate limits of said City be. and the same are hereby extended to include the above described tract of land provided however, that the said tracts are admitted to the City of Tulsa, Oklahoma, upon the condition and subject to the granting of a perpetual easement by the owners of said tracts of land to the city of Tulea, Oklahoma, giving to the City of Tulea, a perpetual right and easement to
