ORDINANCE NO.2557.

COMPARED

An Ordinance adding and annexing to the City of Tulsa, Oklahoma, a certain tract of land within Tulsa County, Oklahoma, described as follows, to-wit: Beginning at a point on the third Guide Meridian, known as the center line of Peoria Avenue (30) thirty feet West of the Northwest corner of Lot 11, Block 5, of Lynch & Forsythe's Addition; thence North along the third Guide Meridian a distance of three hundred and forty (340) feet (More or less) to the Creek-Chepkee Boundary line; thence East along said Creek-Chepkee Boundary line a distance of four hundred and fifty (450) feet (more or less) to the Northwest corner of Lot 19, Block 4, of said Lynch & Forsythe's Addition. thence South, along the West line of Lot 19 in said Block 4, and Lot 2 in the above described Block 5, a distance of three hundred and thirty-six and sixty-five hundredths (336.65) feet to a point on the South line of the Alley in the above described Block 5; thence West along the said South line of the Alley a distance of four hundred and fifty and one-tenth (450.1) feet to the point of beginning.

Whereas, it has been made to appear to the Mayor and the Board of Commissioners of the City of Tulsa, Oklahoma, that the hereinafter described tract of land situated in Tulsa County, Oklahoma, lies contiguous to and adjoins the present corporate limits of the City of Tulsa, Oklahoma, on three or more sides.

WHEREAS, it further appears to the Mayor and Board of Commissioners of said City that the said tract of land hereinafter described abuts said City on three or more sides and should be annexed to the city of Tulsa and entered within its corporate limits and that said tract of land does not exceed forty acres.
