A strip of ground, not to exceed ten (10) feet in width, being more particularly described as follows, to-wit: being more particularly described as follows, to-wit:

The East ten (10) feet of Lot 15, Block 10, Woodward Park Addition to the city of Tulsa, Oklahoma, according to the duly recorded plat thereof.
