REVOCATION OF AUTHORITY UNDER TRUST DEED, DECLARATION  
OF TRUST AND APPOINTMENT OF TRUSTEE.

KNOW ALL MEN BY THESE PRESENTS:

COMPARED

That, whereas, there now appears of record in the office of County Clerk of Creek County, State of Oklahoma, an instrument designated as "Trust Deed, Declaration of Trust, Appointment of Trustee, and Acceptance of Trustee" recorded in Book 294 at page 91 thereof, purporting to have been executed by the undersigned on the 8th day of August, 1923, and purporting to convey, transfer, assign, deed and set over unto one J. H. Lilley, of McAlester, Oklahoma, divers real and personal property described in said instrument, to be held by him in trust for a term of ten years for those certain beneficiaries therein named, and purporting to grant unto the said J. H. Lilley certain powers as such trustee over and concerning said property and estate of the undersigned, a part of which is described as follows:
