Jorunal Entry of JUDGMENT Quieting Title.

vs. Fornia Hickman and J. B. Hickman, Defendants.

Now on this 24th day of January 1924, being one of the regular judicial days of the November Term of said court, this cause comes on to be heard in its regular order; and the plaintiffs appeared by their attorney, C.T. Byrd, and the defendants, Fornia Hickman and J. B. Hickman, and each of them having been three times called in open court to appear, except demur, answer or plead, to the petition of plaintiffs herein, came not, but each of them makes default. And the court having ordered that said defendants, and each of them, are in default and having ordered that the allegations contained in plaintigg's petition be taken as condessed; and it appearing to the court that said defendants and each of them have been duly notified more than twenty days prior to this date of the pendency of this action as required by law, by publication of notice thereof for three consecutive weeks in the Sand Springs Leader, a newspaper printed and of general circulation in Tulsa County, State of Oklahoma; and the court having heard all the evidence and the oral testimony of witnesses sworn and examined in opern court, and being fully advised in the premises, and on consideration thereof. finds that all the averments of plaintig's petition are true as therein set forth; that Laura B. Williams, deceased, died seized of, together with her brother, Claude Wilson, the following described real estate situated in Tulsa County, Oklahoma, to-wit: Lots thirteen (13), Fourteen (14) fifteen (15) and Sixteen (16) in Springdale (acre) Addition to the city of Tulsa; that H. W. Conyers is the regularly appointed, qualified and acting administrator of the estate of the said Laura B. Williams, deceased; that the said Claude Wilson is seized of an undivided interest in said real estate. The court further finds that the said Laura B.
