clear and discharged of and from all liens and incumbrances of whatsoever nature and kind, except as above set forth.

IT IS FURTHER COVENANTED AND AGREED by and between the parties hereto, their heirs and assigns, that said real estate for a period of ten years from April 24, 1919, shall not be used for other than residence purposes; that only one residence shall be constructed upon any one lot; that the residence and other improvements hereafter constructed on said lot shall cost not less than 3--; that no building or any projecting part thereof shall extend within twenty-five feet of the front property line, except entrance approaches without roof that for a period of twenty-five years from April 24, 1919, the same shall not be sold, conveyed, leased is rented to any person of African descent, commonly called negroes, nor shall any person or persons of such descent, during said period of time, occupy the same or any part thereof, except while employed or acting as servants for the owner or lessee of said property; nor any billboards or other means of advertising shall be located on any part thereof.
