

above described lands and the assigness of such part or parts shall fail or make default in the payment of the apportionate part of the rents due from him or them such default shall not operate to defeat or affect this lease in so far as it covers a part or parts of said lands upon which the said lessee or any assignee thereof shall make due payments of said rental.

Lessee shall faithfully continue the drilling of the well until the sand has been reached from which wells in the vicinity are producing in commercial quantities, which is known as the Wilcox sand.
