AGREEMENT .

THIS AGREEMENT made and entered into this 15th day of November, 1922, by and between R. P. Brewer, N. R. Graham and H. C. Jacobus, of Tulsa, Oklahoma.

WITNESSETH: THAT WHEREAS, the parties hereto have purchased a certain tract of land in Tulsa County, State of Oklahoma, described as follows, to-wit:

The Southeast Quarter (SE1) of Section Thirty-four (34), Township Nineteen (19) North, Range Eleven (11) East,

AND WHEREAS, the deed to said property was executed by Willie Inscho and Helen Turner Inscho. his wife, to H. C. Jacobus, Trustee.

AND WHEREAS, as a part of the consideration for said deed, the said H. C. Jacobus, as Trustee, agreed to assume and pay a certain mortgage indobtedness now upon said land in the sum of Four Thousand Five Hundred Dollars (\$4,500.00), due May 1, 1923, with interest at six percent (6%) per annum from May 1, 1922, held by Conservative Loan Company, of Shawnee, Oklahoma, and also executed a certain promissory note to Willie Inscho and Helen Turner Inscho dated November 14, 1922, and due November 13, 1923, in the sum of Two Thousand Six Hundred Dollars (\$2,600.00), with interest from maturity at the rate of eight per cent (8%) per annum.

NOW THEREFORE, it is understood and agreed by and between all parties hereto that said H. C. Jacobus, Trustee, holds the record title to the above described real estate as Trustee for said R. P. Brewer, N. R. Graham and H. C. Jacobus, and that each of said parties is the owner of an undivided one-third interest therein, subject to the payment of the above mentioned indebtedness, and that said H. C. Jacobus, Trustee, executed said above described instruments as Trustee for said parties, and that each of said parties owes one-third of said indebtedness, and each of said parties hereby assumes and agrees to pay one-third of said indebtedness, as evidenced by said note and said mortgage mentioned in said deed, and as evidenced by said note executed by said H. C. Jacobus, Trustee.
