That during her lifetime he knew Lizzie Cherry Fields; that affiant and said Lizzie Cherry Fields were married at Huntsville, Missouri, in June, 1911; that in August, 1911, said Lizzie Cherry Fields came to Oklahoms; that in September. 1911, affiant also returned to Oklahoma;

That said Lizzie Cherry Fields, upon coming to Oklahoma in said month of August, 1911, went to live with her mother at Oktaha.
