NOW, THEREFORE, in consideration of the sum of \$1.00 it is agreed by and between the parties hereto that the said S. C. Carney shall have an easement or a right of ingress and egress for private automibiles over the land covered by the said driveway to the garage on the back of the said lot, and the said Robt. E. Adams and W. Frank Walker do have an easement in and to the lands of the said S. C. Carney covered by the said driveway for private automobiles, same being the right of ingress and egress to the said garage, and each of the parties hereto agree to bear their proportionate expense of the maintenance and upkeep of said driveway.
