For and in consideration of the use of and connection with the sewer system in SEWER DISTRICT NO.135, of said City of Tulsa, and the covenants and agreements herein contained, the said part- of the second part do hereby covenant and agree with the said City of Tulsa, Oklahoma, as follows, to-wit:

That the said part- of the second part-- the fee owner of the following property covered by this contract, to-wit:

A triangular strip of land lying south of the Katy railroad, east of Peoria

street and north of Block 1 Sunset Addition to the city of Tulsa, Okla.
