RIGHT OF WAY GRANT.

KNOW ALL MEN BY THESE PRESENTS, That I. Trett of the post office of West Tulsa in the State of Oklahoma for and in consideration of Two -- 50/100 Dollars, cash in hand paid, receipt of which is hereby acknowledged, does hereby grant and convey unto THE TEXAS PIPE LINE COMPANY of Oklahoma, a corporation of Oklahoma, the right to lay, operate and maintain a pipe line for the transportation of oil or gas, the grantee selecting the route, upon, over and through the following described land, situated in the County of Tulsa in the State of Oklahoma:

Lot B, Block 6 Garden City Addition to city of Tulsa, Okla.

Also the right to locate, erect, operate and maintain upon, over and through said land, a line of poles, and telegraph and telephone wires thereon, and the grantee at any and all reasonable times shall have the right of ingress to and egress from such pipe lines and telegraph and telephone line, and may remove the same in whole or in part at will.
