ARTICLE -1

The Trustees under this agreement shall be, unless and until changed as herinafter provided

ARTICLE -11

The Trustees in their collective capacity and so frar as practicable and convenient shall be designated bym and act under the name of NORWIN COMPANY and under that name shall, so for as practicable conduct the business and excute any instruments in writing in the performance of i this trust,

ARTICLE -111

That association shall continue in existence for the perdod of twenty-one years from and after the date of the signing of these presents, and until the death of that one of said member persons who shall last die, unless such association is soomer dissolved as hereinafter provided,
