One Thousand and no .100 Dollars to them duly paid, the recipt of which is hereby acknowledged have sold and by these presents do grant, bargain, sell and mortgage to the said parties of the secon part, its successors or assigns forever, all that tract or parcel of land situated in the County of Tulsa and State of Oklahoma, described as follows. to-wit:
