My said Trustee is further dathorized to pay all taxes, charges and costs of administration and other necessary expenses incurred in the administration, preservation and protecttion of the property held in this trust, all at su ch times and to such persons and at such places as shall be proper, lawful and expedient. I expressly direct that said Trustee shall have the power of dete mingtion how all receipts and disbursements shall be credited, charged or appropriated as between income and principal and the decision of my Trustee shall be final and not subject to question by the beneficiaries of the trust herein created,

THIRD, This trust is created for the use and benefit of my brother, Samuel E, Misener of Drumright, Oklahoma, and his wife, Mary UMisener, and my brother James E, Misener, of Susanville, California, and for my two daughters Genevieve Misener Moore and Lillian J, Misener, both of Tul a, Oklahoma.,

FOURTH: I direct that there shall bepaid to my brother Samuel E, Misener, of Drumright Oklahoma, the sum of Seventy (\$70,00) Dollars per month, which payment shall commence on April 1stm 1924, and Seventy (\$70,00) Dolla rs on the first day of each month thereafter during his kife time, That upon his death, if his wife, Mary Hisener, Survives hism this payment of eventy (\$70,00) Bollars per month shall be made to her during her life time,

In the event of the death of either one or both of my said daughters before final distribution of this trust to them. then the portion of this trust that would go to said deceased daughter shall be distributed to her heirs at law according to the laws of descent and distripution in force in the State of Oklahoma at the time of her death ,

Sixth, I hereby expressly direct that the beneficiaries under this trust are hereby restrained from and shall be without right, power or authority to sell, transfer, pledge, nortgage, hypothecate, alienate, anticipate or in any other manne. affect or impair his, her or their beneficial and legal rights under this toust during the entire term hereof, or any portion of the same, ner shall this trust be subject to the rights or claims of any crededitors of said beneficiaries, nor shall the same be liable to any process of law, and the

fincome from this trust shall be transferable, payable and deliverable solely and exclusively to the above designated peneficiaries and then only at the time entitled to take the same under the terms of thei trust, and the personal receipts of the designated beneficiaries hereunder shall be a condition precedent to the payment or delivery of the same to each beneficiary by said Trustee.
