For the purposes of ascertaining such compensation, the reasonable value of the trust estate inhereby agreed to bethe par value of all mortgages, notes, bonds and securities held in this trust,

For any extraordinary services rendered in the execution of the trust, a reasonable compensation shall be allowed the Trustee therefor.

EIGHT. This trust shall be irrevocable.
