

ful claims of all persons whomsoever, Said first parties agree to insure the buildings of said premises in the sum of (\$ ) for the benefit of the mortgagee, its successors and assigns and to maintain such insurance during the existence of this mortgage, Said first parties also agree to pay all taxes and assessments lawfully assessed against said premises before the same shall become delinquent,

Now if said first parties shall pay or cause to be paid to said second party, its successors and assigns, said sum or sums of money in the above described note mentioned, together with the interest thereon according to the terms and tenor of said note, and shall procure and maintain such insurance and pay such taxes and assessments, then these presents shall be wholly discharged and void; otherwise shall remain and be in full force and effect, If such insurance is not effected and maintained or if any and all taxes and assessments which are or may be levied and assessed lawfully against said premises, or any part, thereof, are not paid before the same become delinquent, then the mortgage herein its successors or assigns may effect such insurance and pay such taxes and assessments and shall be allowed interest thereon at the rate of ten (10) per cent per annum until paid, and this mortgage shall stand as security for all such payments and sums; and if said sum or sums of money or any part thereof, or any interest thereon is not paid, when the same becomes due and payable, or if such insurance is not effected and maintained and the certificates or policies, delivered to said second party, its successors or assigns, or if any taxes or assessments are not paid before the same shall be delinquent, the holder of said notes and this mortgage may, without notice to first parties, elect to declare the whole sum or sums and interest thereon and attorney's fees therein provided for due and payable at once and proceed to collect said debt, interest and attorney's fees set out and mentioned in said note, according to the terms and tenor thereof and also all sum paid for insurance and taxes and legal assessments and interest thereon, to the possession of said premises and shall be entitled to the rents and profits thereof, and shall be entitled to the appointment of a receiver for the collection of said rents and profits,

And it is further expressly agreed, that as often as any proceedings is taken <sup>to foreclose</sup> this mortgage, said first parties shall pay to said second party, its successors and assigns, a sum equal to Ten Dollars, and Ten Per Cent additional of the total amount due on said mortgage and on said note as attorney's fees for such foreclosure in addition, ~~in addition~~ to other legal costs, and that such Attorney's fee shall be a lien upon the premises hereinabove described, and a part of the debt secured by this mortgage,
