WHEREAS, It has been made to appear to the Mayor and Board of Commissioners of the City of Tulsa, Oklahoma, that a certain tract of land known as Mixon Trotter Heights Addition to the City of Tulsa, Oklahoma hereinafter particularly described, lying in Tulsa County, Oklahoma, and lying contiguous to and adjoining the present corporate limits of said City is surrounded on three or more sides by the corporate limits of the City of Tulsa and abuts on the City of Tulsa on three or more sides, and
