be and the same is hereby added and annexed to said °City of Tulsa to be known as Mixon Trotter Heights Addition to seid City and that the corporate limits of said City be and the same are hereby extended to include the above tract of land.

SECTION 2. That the City of Tulsa, Cklahoma, hereby retains and reserves a perpetual easement and right to enter upon and use any portion of the above described tract of land and to build, construct, lay, maintain, alter or repair any sewer lines, water lines gas lines, telephone li es, telegraph lines, electric lines or any other public utilities.

SECTION 3. That from and after this ordinance takes effect the real estate described in Section 1 hereof shall be a part of the City of Tulsa, Oklahoma, and all persons residing therein and all property situated thereon, shall be and is hereby declared to be subject in all respects and particulars to the jurisdiction, control and laws and ordinances of said City of Tulsa, Oklahoma.

SECTION 4. That an emergency exists for the preservation of the public peace, health and safety, by reason whereof this ordinance shall take effect from and after its passage, approval and publication.
