ORDINANCE NO. 1528.

An Ordinance accepting, assenting and adding to the City of mTulsa Oklahoma, Lots 2 and 3, in Block 1, of the Riverford Addition to the City of Tulsa, Okalhoma; and declaring an emergency.

WHEREAS, A petition has heretofore been presented to the Mayor and Board of Commissioners of the City of Tulsa, Oklahoma, signed by the owners of Lots 2 and 3, in Block 1, of the Riverford Addition to the City of Tulsa, Oklahoma, said lots lying contiguous to and adjoining the present city limits of said City, said petition praying that this Board annex to said Citysaid lots; and

WHEREAS, It appearing upon examination by this Board that the territory sought to be annexed is platted into lots and blacks and is nownused for residential purposes and that said petition is duly signed by the owners of said lots, and it further appearing to this Board that the Prayer of said Petition is right and proper and said land should be annexed to the said City of Tulsa, and that said action is for the best interests of the inhabitents thereof,

NOW, THERETO re, BE IT ORDAINED BY THE BOARD OF COMMISSIONERS OF THE CITY OF TULSA, OKLAHOMA

Section 1. That Lots 2 and 3 in Block 1 of the Riverford Addition to the City of Tulsa, Oklahoma, be and the same are hereby annexed to and made a part of said City of Tulsa, and that the corporate limits of said City of Tulsa, be and the same are here by extended to include the above described lots.

Section 2. That from and after this ordinance takes effect said lots mention ed in Section 1, hereof, be and the same are hereby declared to be a part of said City of Tulsa, Oklahoma, and all persons residing therein and all property situated therein be subject in all respects and particulars to the jurisdiction and control, laws and ordinances of said City of Tulsa.

Section 3. That an emergency exists for the preservation of public health and safety, by reason whereof this ordinance shall take effect from and after its pass age, approval and publication.

Passed and the emergency clause ruled upon separately and approved this 6th. day of June, 1916.
