said Mortgagors waive notice of election to declare the whole debt due as above provided and also the benefit of stay, valuation or appraisement laws. All of the covenants agreements and terms contained herein shall be binding on the mortgagors, their heirs, ersonal representatives and assigns and shall be for the benefit of the mortgagee, its successors and assings,
