Lots Thirteen (13), Fourteen (14), Fifteen (15) and Sixteen (16) in Block Seven (7) in Maple Ridge Addition to the City of Tulsa, Oklahoma, according to the official plat thereof duly recorded in the office of the County Clerk within and for Tulsa County, O Oklahoma.

TO HAVE AND TO HOLD THE SAME, Together with all and singular the tenements, hereditements and appurtenances thereunto belonging or in any wise appertaining forever.
