Lot 36 and 37 Colck "B" Farm Colony Addition

Also the grantee at any and all reasonable times shall have the right of ingress to und egress from such pipe lines and telegraph and telephone line, and may remove the same in whole or in part at will

TO HAVE AND TO HOLD the said easements unto said The Texas Pipe Line Company of Oklahoma its, successors and assigns, so long as such structures are maintained.
