WITNWSSETH, That the said parties of the first part, in consideration of the debt and trust hereinafter mentioned and created and the sum of One Dollar to them paid by the party of the second part, the receipts of which is hereby acknowledged, do by their presents, Grant, Bargain Sell <sup>C</sup>onvey and <sup>C</sup>onfirm unto the said party of the second part, the following described Real Estate, situated in the <sup>C</sup>ounty of Tulsa, and State of <sup>C</sup>klahoma to-wit:

The East 38.5 feet of Lot One (1) Block Bleven (11) Meadowbrook Addition to the City of Tulsa, TulsaCounty, Oklahoma, according to the recorded plat thereof. and Certificate number 896 being for 4 3/8 share of "D" Stock in the CENTRAL SAVINGS AND LOAN ASSOCIATION, of marshall, Missouri, and possession of said premises and said shares of stock is now delivered unto the said party of the second part.

TO HAVE AND TO HOLD THE same with all the rights and pppurtenances thereto belonging to the slid party of the second part and to his successor hereinafter designated, and to the assigns of him and his successor, forever.

In trust, however, for the following purposes: WHEREAS, the said ". H. Agard and W. ## NOTE OF OBLIGATION

Tulsa, Okla., April 1st, 1924

One "undred months after date, for value received, We promise to pay to the CENTRAL SAVINGS AND LOAN ASSOCIATION; of Marshall, Mo., Seventeen Hundred F ifty Dollars, this day advanced to me as a loan, with interest thereon at the rate of six per cent per annum, payable in monthly installments of eight & 75/100 Pollars each, and the further sum of Four & 37/100 "ollars per month, for premium on said loan so made to us by said CENTRAL SAVINGS AND LOAN ASS ociation, Marshall, Mo., and We further agree to pay said Association, at the same time said interest and premium are payable the sum of Thirteen & 13/100 Dollars every month, the same being the monthly dues on Certificate No 896 of the capital stock of the said CENTRAL SAVINGS AND LOAN ASSOCIATION this day pledged by us as collateral security for the payment of said loan so advanced to us, And we further agree to pay to the said association all of the said sums of money, amounting in the aggregate to Twenty six & 25/100 Dollars on the first Saturday of each and every month until the said Certificate <sup>N</sup>o 896 so pledged by us as collateral security to said loan, shall, according to the By-Laws of the said Association, reach the ultimate or par value thereef, or said loan shall be otherwise sconer canceled or discharged.

In default of payment of said sums of money so expressed to be for dues interest and premiums, as aforesaid, and within the time required by the By-Laws of the said Association, We agree to pay all fines and penalties assessed against us for said default, PROVIDED. That the maker hereof may at the end of One Hundred months cease making said monthly payments, as aforesaid, and may take credit upon the said loan so advanced for the then book value of the said Certifiwate No 695 so pledged to secure this loan, and may pay to the said Association the differance, if any, between said book value of said Certificate and said loan, and may thereafter
