I Claude Macy do hereby acknowledge that a certain Mortgage, bearing date the 8th day of February, 1923 made and executed by T. F. Renfrew & Ella Renfrew to Claude Macy to secure the payment of Twenty five hundred & No/100 \$ Dollars, on the following described real estate in the County of Tulsa, and State of Oklahoma, to-wit:

Situated in the County of Tulsa, State of Oklahoma to-wit: That part of the Northeast Quarter (NE $\frac{1}{4}$) of the southeast quarter (SE $\frac{1}{4}$) of Section three (3) Township Nineteen (19) North, Range Twelve (12) east of Indian Base and Meridian, described as Follows: Commencing at the northeast corner of the said northeast quarter (NE $\frac{1}{4}$) of the Southeast Quarter (SE $\frac{1}{4}$) of said section three (3) and from thence running south on the section line between said section three (3) and section two (2), 797.3 feet. Thence west 32 feet, more or less parallel with the south boundary line of Admiral Boulevard, to the west boundary line of the new Highway, being the point of beginning. Thence from this point of beginning running west parallel with Admiral Boulevard to a point 355 feet west of the section line between said section three (3) and section (2) Thence north parallel with said section line 50 feet. Thence west parallel with Admiral Boulevard 175 feet, Thence south 23 feet more or less to a point on a diagonal line running from the northeast corner of said North east quarter of the southeast quarter of said section three (3), to the southeast corner of the said northeast quarter of the southeast quarter of said section three (3) and from said point on said diagonal line running southeast on said diagonal line 350 feet more or less to within 125 feet of the place where the west boundary line of the new highway intersects the said diagonal line.
