Lots One, Five and Six being that portion of the Northeast Quarter and the Southeast Quarter of Section Eighteen (18) lying North and East of the Arkansas River in Township Dighteen (18) North, Range Thirteen (13) East, together with other property.

And. Whereas, said parties of the first part now claim to be theowners of a strip along the northeast line of said Arkansas River and the riparian rights accruing thereto.
