(21) bears, then the whole of said trust estate with its accumulations, if any, shall be transferred, conveyed and delivered to The University of Kansas at Lawrence, to have and to hold the same forever for and upon the following trusts, purposes, uses and conditions, to-wit: -- Said (Signed Pearl M. Wheatley.) fund shall be known as The George W. Wheatley Scholarship Fund and the same shall be invested and reinvested from time to time in interest bearing securities, and the income therefrom whall be used for the purpose of defraying in whole or in part the expenses of poor, but worthy, young men attending such University. Said fund shall be administered under such rules and regulations as shall be prescribed by the Chancellor and faculty of said University.

In case of the death of the said Frederic Helen Wheatley, prior to his attaining the age of twenty-three (25) years and without legitimate tasue him surviving, then and in that event, I direct that the said trust estate shall be dissolved and the same, with its accumulations, if any, be immediately distributed as follows:

(a) twill and direct that the real property inherited by me from my Mother be transferred conveyed and delivered to my sister, Mrs. Maie E. Rogers, and to my brother, Aaron B. Colean share and share alike, to have and to hold the same to them and their heirs absolutely and forever.

(b) I will and direct that all the rest and desidue of said trust estate be divided, tradsferred, conveyed and delivered,

One Third (1/3) to my sister, Mrs Maie E. Rogers

One Third (1/3) to my nephew, Walter M. Clover, and

One Third (1/3) to N. B. Edmiston,

to have and to hold the same tothem and their heirs absolutely and forever: provided, however that in the event of the prior death of my sister, Mrs. Maie E. Rogers, I will and direct that all of the property mentioned in paragraph 5- above, being the property inherited by me from my Mother, be transferred, conveyed and delivered to my brother, Aaron B. Colean, to have and to hold the same absolutely and forever, and that all the property mentioned in paragraph 5-b be transferred, conveyed and (Signed Pearl M. Wheatley) dilivered as follows:--

to my niece, Ruth Colean \$500.00

to my niece, Anna B. Colean, \$500.00,

to Wayne Clover, son of Walter M. Clover, my library of miscellaneous books,

to Tae and Hester Clover, daughters of the said Walter M. Clover, twelve (12) hand painted plates.

to my Brother-in-Law, I. B. Wheatley, one oil painting,

to my nephew, Walter M. Clover, one oil painting,

to N. B. Edmiston, all the rest of my pictures, paintings, china, silverware, and household furnishings.

*11 the balance of said trust estate shall be distributed equally between the said N. B. Edmisto, if living, and the said Walter M. Clover, or his heirs by right of representation; and in the event of the prior decease of the said N. B. Edmiston, then all of the balance of the said trust estate shall be delivered and conveyed to the said Walter M. Clover, or his heirs by right of representation.

Fourth: -- Should any of the gifts and bequests made by me in the Third Section of this, my last will and testament, lapse or fall, for any reason, I will and direct that the bequest so lapsing shall go to the University of Kansas at Lawrence, Kansas, for the uses and purposes and upon the conditions contained in the Third Section, paragraph Four (4) above.

Fifth:-- I nominate W. L. Biggs of "uskogee, Oklahoma, guardian of my said adopted son, Frederic "llen Wheatley, during his minority and I ask that he serve without bond. "t is my
