by reason of legal proceedings instituted by an outside person or persons, then and in that event it is agreed that party of the second part shall be granted an allowed such an additional extension of time for the commencement of said well as may be required to dispose finally of said legal proceedings, not, however, beyond the term provided for in said oil and gas lease: in case such an action is or should be brought by outside parties, the parties hereto agree to co-operate together and to use all reasonable means to combat successfully any such action;

It is understood that this agreement shall be binding upon the heirs, successors, personal representatives, executors, administrators and assigns of the parties hereto.
