ORDER CONFIRMING SALE OF REAL ESTATE

" An order having been made by this court on the 24th day of May, 1924, authorizing Lela Williamson, as Guardian of the estate of Virgil Clinton Cole, a minor, to sell certain real estate belonging to the said minor; and thereafter, on the 18th day of June, 1924, the said Lela Williamson, as Guardian of said minor, Virgil Clinton Cole, having made to, this court and filed in the office thereof a return of her proceedings under the said order of sale, and duly returned to this court an account of sale verified by affidavit of the said Lela Williamson, as Guardian of the said minor, and this court having examined the said return, and having in open court also examined the said Lela Williamson, as Guardian, and it appearing to the satisfaction of this court that in pursuance of the said order of sale, Lela Williamson, as Guardian of the said minor caused notice of the time and place of holding said sale to be posted up in three of the most public places in said county, one of which was at the County Court House in said County, in which the land ordered sold is situated and to be published in the Tulsa Daily Legal News, a newspaper printed, and of general circulation, in said County, for two successive weeks successively next before such sale, in which notice the lands and tenements to be sold were described with common certainty; that at the time and place of holding such sale specified in said notice, the said Lela Williamson, as Guardian of the said minor, caused to be sold at public auction to the highest and best bidder, upon the following terms, to-wit: cash upon confirmation of sale by the court, and subject to confirmation by the court, all of the right, title and interest of the said minor, the same being an undivided one twenty-seventh interest in and to the following described real estate in the City of Tulsa, Tulsa County, Oklahoma, to-wit:

> Lots One (1) and Two (2) in block Fifteen (15), Orcutt Fark Addition to the said City, according to the recorded plat of said, addition;

that at such sale Jay Marek became the purchaser of said interest of the said minor in and to the said real estate for the sum of \$185.19, he being the highest and best bidder, and the said sum of \$185.19, being the highest and best sum bid for the interest of said minor in and to the said real estate above described.
