ASSIGNMENT OF OIL AND GAS LEASE.

Graham or....., hereinafter referred to as the party of the first part, is desirous of selling an undivided Seven Thirty second interest in and to said oil and gas mining lease, and Grahama Oil Co. corporation of Tulsa, Oklahoma, hereinafter referred to as the party of the second part, is desirous of buying an undivided Seven (7) thirty second interest in said oil and gas mining lease.

NOW, THEREFORE, For and in consideration of the sum of One Dollar, in hand paid to the party of the first part by the said party of the second part, receipt of which is hereby acknowledged, together with the conditions, covenants and agreements hereinafter contained and set forth and to be performed and kept by the parties hereto, their successors and assigns the said party of the first part doeth hereby assign, set over, transfer and convey unto the said party of the second part, his successors and assigns, an undivided 7-32nd interest in and to the oil and gas mining lease aforesaid, and all the rights thereunder or incident thereto; insofar as it covers the above described real estate, including the drilling of a test well to
