KNOW ALL MEN BY THESE PRESENTS, That Nammie Lewis of the post office of Turley in the State Of Oklahoma for and in consideration of Ten ...No/100 Dollars, cash in hand paid, receipt of which is hereby acknowledged, does hereby grant and convey unto The Texas Pipe Line Company of Oklahoma, a corporation of Oklahoma, the right to lay, operate and maintain a pipe line for the transportation of oil or gas, the grantee selecting the route, upon, over and through the following described land, situated in the County of Tulsa, in the State of Oklahoma:

SE 1/4 of SE 1/4 Sec 36 Twp 21 N- Rge 12 E

also the right to operate, and maintain, adjacent to and parallel with the first, a second pipe line; and the grantee at any and all reasonable times shall have the right of ingress to and egress from such pipe lines and may remove the same in whole or in part at will.

TO HAVE AND TO HOLD the said easements unto said The Texas Pipe Line Company of Oklahoma, its successors and assigns, so long as such structures are maintained.
