Tracy, her husband, parties of the first part, for and in consideration of the sum of Three -housand Six Hundred (\$3,600.00) Dollars, to them in hand paid, the receipt of which is hereby acknowledged, and the further consideration of the covenants and agreements hereinafter set forth do hereby grant, bargain, sell and convey unto J. C. Parks party of the second part, his heirs and assigns, the following described real estate situate in the City of Tulsa, in Tulsa County, Oklehoma, to-wit:

All of Lot Twelve (12) in Block Seven (7) in Childers Heights Addition to the City of Tulsa,

Addition to said City of Tulsa, as shown by the executed Plat thereof filed and recorded in the Office of County Clerk of said County and State, and said grantors represent that said real estate is no part of their homestead or that of their family; and warrants and defends the title to the same against all lawful claims whatsoever, except unmatured installments of special Assessments and an easement five feet wide along rear property line granted to said City of Tulsa as shown by Deed of Dedication executed and recorded April 24, 1918.
