COMPARED

That the ARKANSAS NATURAL GAS COMPANY, a corporation, duly organized and existing under and by virtue of the laws of the State of Delaware, herein represented by J. C. Trees, its President, duly authorized by Resolution of the Board of Directors, for and in consideration of the sum of ONE (\$1.00) DOLLAR cash and other valuable considerations paid by the ARKANSAS FUEL OIL COMPANY, a corporation, duly organized and existing under and by virtue of the laws of the State of West Virginia, the receipt of which is hereby acknowledged and the further considerations hereinafter mentioned, has granted, bargained, sold, and conveyed, and does by these presents grant, bargain, sell and convey unto the said Arkansas Fuel Oil Company, its successors and assigns all of its entire right, title and interest of, in and to the following certain oil, gas and mineral leases covering lands situated in Tulsa County, Oklahoma, to-wit:

1. That certain lease executed by John A. Robinson and Keo M. Robinson, his wife, in favor of H. "N". Gard, dated January 9th, 1923, recorded in Tulsa County Records, containing 20 acres, more or less; only in so far as the said Lease covers and applies to the NW $\frac{1}{4}$  of SE $\frac{1}{4}$  of NW $\frac{1}{4}$  Section 8, Township 20, Range 13.
2. That certain lease executed by Geo. E. Hanover and Susan Hanover, his wife, in favor of H. R. Gard, dated January 13th, 1923, recorded in Tulsa County Records, covering the W $\frac{1}{2}$  of NW $\frac{1}{4}$  Section 8, Township 20N. Range 13E, containing 20 acres, more or less.
3. That certain lease executed by Claude Morris et al in favor of H. R. Gard, dated August 5th, 1922, recorded in Tulsa County Records, covering the SW $\frac{1}{4}$  of SE $\frac{1}{4}$  of NW $\frac{1}{4}$  Section 8, Township 20, N. Range 13E, containing 10 acres, more or less.
4. That certain lease executed by Frank M. Mahan and Annie R. Mahan, his wife, in favor of Harry R. Gard, dated August 5th, 1922, recorded in Tulsa County Records, covering the E $\frac{1}{2}$  of E $\frac{1}{2}$  of NW $\frac{1}{4}$  SECTION 8, Township 20N, Range 13E, containing 40 acres, more or less.
