WHEREAS, Illinois Trust and Savings Bank, a banking corporation, organized and existing under and by virtue of the laws of the State of Illinois, with its principal office in the City of Chicago, County of Cook and State of Illinois, was heretofore named as Trustee in a certain Trust Deed hereinafter described, and afterward, on the 7th day of April, A. D. 1923, was, under the laws of the State of Illinois, consolidated with The Merchants Loan and Trust Company, an Illinois corporation, under the name of Illinois Merchants Trust Company, as evidenced by certificates filed on the 7th day of April, A. D. 1923, in the office of the Secretary of State of the State of Illinois, at Springfield, Illinois, and filed on the 7th day of April, A. D. 1923, in the Recorder's Office, in Cook County, Illinois, as Documents Numbers 7872317 and 7872318, respectively; NOW, THEREFORE,

KNOW ALL MEN BY THESE PRESENTS, That ILLINOIS MERCHANTS TRUST COMPANY, a corporation duly organized and existing under and by virtue of the laws of the State of Illinois, as Trustee, for and in consideration of the sum of One Dollar (\$1.00) and other good and valuable considerations, the receipt whereof is hereby acknowledged, hereby remises, releases and quit-claims unto

THE TULSA STREET RAILWAY COMPANY,

all right, title, interest, claim and demand whatsoever, that Illinois Merchants Trust Company and said Illinois Trust and savings Bank may have acquired in, through or by a certain Indenture of Trust dated February 1, 1917, and recorded in the office of County Clerk in the County of Tulsa and State of Oklahoma, February 23, 1917, as Document number 91522, to the following described property:

Situate in Tulsa County, State of Oklahoma, to-wit:

The West forty (40) feet of Lots One (1) and Two (2) in Block seven (7), of Orcutt Addition, Tulsa, Oklahoma, according to the recorded plat thereof.

The said forty feet include a strip five (5) feet in width, West of and adjacent to said Lots One and Two, and being the East half of a ten foot alley, which has been heretofore vacated by said City.

This release is not intended to change, modify, abridge, waive, diminish, discharge or affect in any way the lien of said Indenture of Trust upon the property therein described other than that above expressly mentioned; it being expressly understood and agreed that the lien of said Indenture of Trust shall remain and be in full force and effect, and it is expressly retained as to all such other land and property wheresoever situated.
