AFFIDAVIT

Now on this 16th day of February , 1924, personally appeared before me E. S. Shidler, a notary public in and for Osage County, Oklahoma and being duly sworn, John Pecan, upon his oath deposes and says:

That he is the step-father of Ida Littleton; that he was some three or four years prior to the making of this affidavit, duly, legally, and properly appointed guardian of Ida Littleton by the County Court of Potawatomi County; that the reason for his said appointment as guardian was the minority of the said Ida Littleton, who was at that time, approximately Fifteen years of age; and who had a chose in action;

That the said guardian ship continued until January 23, 1924, at which time it was terminated by the said Ida Littleton becoming of age; that on the 23rd day of January, 1924, the said Ida Littleton become of age; that since that time, I, as guardian, have made a full and complete settlement with the said Ida Littleton and have turned over to her, all of her said property and estate of every nature whatsoever, and she now has full power and authority to convey the same and to make such other use of her property as to her may seem fit; that I have no liens or claims against any land or property of the said Ida Littleton for any guardianship fees, salary, debt or remuneration for any services as guardian or for any other reason.
